SPECIAL AIR TRAFFIC PROCEDURES

TAMPA, FLORIDA

January 8 – January 10, 2017

In anticipation of a large number of aircraft operating to and from Tampa, Florida metropolitan area during the NATIONAL COLLEGE FOOTBALL CHAMPIONSHIP week, the following procedures will be used to enhance safety and minimize air traffic delays.

SECURITY PROVISIONS

Special security provisions will be in effect for this event including (but not limited to) Temporary Flight Restrictions (TFRs), two-way communication and discrete transponder requirements. Specific procedures contained in this NOTAM may be revised and access to some airports may be restricted. Pilots are encouraged to check NOTAMs frequently to verify they have the most current information.

TFR information is normally disseminated by FDC NOTAM 3 to 5 days prior to the event. Once published, text and graphical depictions of restrictions may be found on the following web site:

Pilots should be prepared to provide documentation including personal identification, certificate number, aircraft ownership information, and contact information.

TRAFFIC MANAGEMENT

Traffic management initiatives will be utilized when arrival rates exceed airport capacity. Pilots should be prepared for potential airborne holding, reroutes, or Expect Departure Clearance Times (EDCT's) that may be issued for all domestic IFR arrivals to the following airports:

Traffic management initiatives for this event are designed to provide equitable airspace access. To maintain program integrity and minimize delays, airborne changes of destination to above listed airports will not be accepted within 200nm of destination, except in emergency situations. Duplicate flight plans (same time/call sign) to multiple airport destinations are subject to removal from the system.

AIRFILES

Airfiles and changes of destination from airborne flights to airports listed in this NOTAM will not be accepted except for emergency situations while this program is in effect.

AIRPORT INFORMATION

Practice approaches to airports within 40 NM of TPA and touch-and-go/pilot training operations at PIE and LAL may be limited or unavailable due to the high volume of traffic associated with the NATIONAL COLLEGE FOOTBALL CHAMPIONSHIP.

Pilots/operators are strongly urged to contact an FBO at the airport of intended landing prior to initiating flight into the Tampa Area to ensure parking availability for either overnight parking or passenger pick-up/drop-off.


DEPARTURE PROCEDURES


From General Aviation Ramp Area:

- Effective **1800 EST Monday, Jan. 8 through 1700 EST Tuesday, Jan. 10** CLEARANCE MUST BE RECEIVED PRIOR TO TAXI. Clearances will NOT be considered valid until the transponder code is issued.
- Monitor Tampa Departure ATIS (128.47) prior to starting engines.
- Contact Ramp Control (TBD) for ramp exit instructions (see ramp diagram A and B for ramp exit points).
- Contact Tampa Ground Control (121.7) when number one holding short at the designated Ramp Exit Point for runway assignment and taxi instructions. Advise Ground Control of call sign, beacon code and ATIS code.
- DO NOT DEPART RAMP EXIT POINT WITHOUT TAXI CLEARANCE FROM GROUND CONTROL.
- Be ready for departure when reaching the approach end of the runway.
- Do not contact tower for takeoff until in the number one position holding short of the runway and ready for departure.

ST PETERSBURG/CLEARWATER

- Do not request IFR departure clearance prior to 20 minutes before estimated time of departure.
- Call for clearance from the hangar. State complete aircraft identification, departure runway, and advise if you are IFR or VFR requesting RADAR service.
- Do not taxi until clearance is received from Ground Control.
- Do not contact tower for takeoff until in the number one position at the runway and ready for departure.
- Do not expect RADAR service once airborne unless you have received a transponder code and departure control frequency from Clearance Deliver/Ground Control.

LAKELAND LINDER REGIONAL

- Monitor ATIS (118.025) prior to calling for clearance.
- Contact Clearance Delivery (121.4) for clearance.
- Do not contact tower until number one at the hold line.

PETER O. KNIGHT

- Do not request IFR departure clearance prior to 20 minutes before estimated time of departure.
- IFR departures contact TPA Approach (119.8) for clearance.

BANNER TOW / ADVERTISING M EDIA AIRCRAFT OPERATIONS

Raymond James Stadium lies within the Tampa Class B surface area. Due to the large volume of traffic in the Tampa International/Raymond James Stadium area, NO waivers or deviations from Class B Mode C transponder requirements will be granted for the National College Football Championship operations.

The number of banner tow/advertising/media operations authorized in the vicinity of the stadium, as well as the time period spent in the area, may be limited by Air Traffic Control.

FLIGHT PLANS AND WEATHER INFORMATION
