RV & CAR/TENT CAMPING

Thank you for your interest in camping at an AOPA Fly-In in 2020! We are excited to have you join us.

- Camping will be available Thursday, Friday, and Saturday nights.
- Arrivals before Thursday will be handled per normal airport operations. You will be responsible for securing your own lodging/transportation off airport property.

RV AND CAR/TENT CAMPING

- All camping is on non-paved surface.
- All Campers must pre-pay and pre-register. Camping position is not assured without reservation.
- Food is NOT provided on the airfield outside of AOPA meal service times. We recommend you bring snacks, water, sunscreen, and rain gear.
- Ice will not be available for purchase at the fly-in.
- Ground transportation is NOT provided to get to locations off site (taxi or rental car reservations must be
- made on your own).
- Portable restroom and shower facilities are provided. Campers should bring their own towels and toiletries with them. Please consider using the showers during non-peak times to ensure availability and hot water.
- Aircraft camping opens at noon Thursday (the day before the fly-in) and closes at noon Sunday (the day following the fly-in).

EARLY ARRIVALS

- Camping NOT permitted prior to Thursday (the day before the fly-in).
- We may not be able to accommodate you in AOPA camping parking if you arrive before Thursday,
 12:00 noon.

CAMPING AREA

- Campers who have registered will be parked in a designated camping area, which may be unpaved. A map detailing the location will be emailed to you approximately 2 weeks prior to the event.
- We are working closely with airport staff to determine the best location for camping. If you are unsure of where to park, contact Erick Webb at the Tickets and Information Tent.
- Park closely to allow as many others to camp as possible.
- Place the attached "C" (for camping) on your dash or other easily visible area to indicate you have paid for your camping spot. You will receive a "C" and a confirmation/informational email approximately 2 weeks prior to the event.

CAMPSITE RULES AND RESPONSIBILITIES

- Pets are NOT permitted on airport property.
- Alcoholic beverage consumption is prohibited on airport property (this may the camping area).
- Smoking is prohibited on airport property.
- Coolers must remain secured at your campsite location.
- This is "primitive camping," so be prepared for your personal comfort.
- There are no water or electrical hook ups available.
- Ice will not be available at the fly-in, so plan to provide your own.

FIRE SAFETY

- Airport management strictly prohibits wood campfires and charcoal grills anywhere on airport property, including the Aircraft, RV, and Car/Tent camping areas. This includes camp stoves, propane burners, etc.
- Factory-installed ovens/stoves in RVs are exempt from this stipulation.

COURTESY

- Keep your campsite clean and your noise levels down.
- We request you observe campsite quiet hours of 9:00 p.m. until 7:00 a.m. to allow others an
- opportunity to enjoy their rest.
- As often possible, please refrain from running generators, especially during quiet hours. (We
- understand there may be medical/health reasons to keep generators running.)
- Leave campsites the way you found them and place all waste in designated receptacles.
- Do not hang laundry or other items.
- Maintain appropriate clothing modesty.
