AOPA PILOT's "BIZAV AND YOU CONTEST," powered by Pilatus Official Rules

WHO MAY ENTER:

Open to all individuals who legally reside in the 48 contiguous United States and the District of Columbia who are 21 years of age or older as of the date of entry and who are owners, operators or employees of a business that might benefit from access to a Pilatus PC-12 aircraft. Winner must be certificated as at least a private pilot as of the date of entry. Employees of the Aircraft Owners and Pilots Association ("AOPA") and/or Pilatus Aircraft Ltd, ("Pilatus") their subsidiaries and related companies, and the trustees, officers, directors, interns, advertising and promotion agencies of each, are not eligible to win. Any person in the immediate family of an employee (including the spouse, children, parents, brothers and sisters of any employee) living in the same household of any such employee is not eligible to win.

HOW TO ENTER:

Submit your name, address, email address, and telephone number to AOPA via email to the email address <u>AOPAPilatuscontest@aopa.org</u> along with a Microsoft Word document or equivalent that describes in 300 words or less how your business would utilize and benefit from a Pilatus PC-12 single-engine turboprop aircraft and what a typical mission might look like. For general planning purposes, the aircraft is approved for backcountry strips provided the load is no more than four passengers and two pilots plus a limited amount of gear and equipment. Actual passenger list, destinations, gear and weather conditions are subject to the sole discretion of Pilatus. Entries must be original. Entries previously published or pending publication, or that violate or infringe upon the copyright or other intellectual property rights of another are not eligible.

By entering the contest, you grant Pilatus and AOPA the right to utilize your entry, your name, voice, images and/or photographs and videos of you taken by AOPA staff in an article to be published in AOPA Pilot magazine, the AOPA website, and/or other media for information and/or promotional purposes . You also agree to acquire the similar written consent of any guest(s) selected by you.

ENTRY DEADLINE:

The contest begins at 00:01 AM, March 1, 2015 and ends at 5:00 PM, June 30, 2015.

JUDGING:

Judging of entries will be conducted by selected editors of AOPA Pilot magazine. Entries will be judged on their originality, composition, handling of the subject matter, appropriateness of the aircraft for the proposed mission and general appeal. Decisions of the AOPA judges will be final. Winning essay will be selected and the winner will be notified on approximately July 10, 2015 by email or telephone.

WHAT CAN I WIN:

The winner will be provided with \$4,000 in cash and up to eight (8) hours of use of a Pilatus PC-12 over no more than four (4) consecutive days with professional crew and fuel for flights within the contiguous 48 U.S. states to fulfill the mission(s) outlined in the original essay or a trip of similar scope as agreed upon by AOPA Editors and Pilatus. The flight(s) will be scheduled at a mutually agreed upon time between the winner, Pilatus, and AOPA editors. However, the trip(s) must be completed by September 18, 2015. The winner may select up to three (3) guests to accompany winner on the flight, subject to Pilatus's approval based on the aircraft capabilities. AOPA will pay for up to three (3) nights lodging and three (3) days meals for winner and guest(s). Winner and guest(s) are responsible for their own transportation to and from the starting and ending points of the trip. An AOPA Pilot editor and photographer/videographer will accompany the flight to document the trip and record the winner's response to the experience. The experience may be published as a story in an upcoming edition of AOPA Pilot and AOPA's website, and may be accompanied by online and video segments as well.

APPROXIMATE RETAIL VALUE:

The approximate retail value of the prize is \$17,000.00. All federal, state and local taxes, fees and other expenses not included above are winner's responsibility.
