## **OFFICIAL RULES**

## 1. NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 2. Must be present at the time of the drawing to win.
- 3. Open to all individual attendees at AOPA's Wings 'n Wheels, May 5, 2018 eight (8) years of age or older as of the date of Entry and ends at 1:00 pm May 5, 2018. If any winner is 8 or older, but less than 18 years of age, the winners' parent or legal guardian may be required to consent to the award of the prize and sign any required consent/affidavit.
