增加运动执照、降低取照门槛，鼓励娱乐和运动飞行

Add LSA pilot license, widen the threshold for obtaining the license, encourage entertainment and sports flying

取消3180kg以下直升机型别等级，促进直升机运行发展

Cancel helicopter type under 3180 kg, promote the development of helicopter operations

修订私照理论考试和实践考试标准，降低私照持有人体检标准，扩大私用飞行员队伍

Revise testing standard of knowledge test and flight test, lower the standard of medical requirement for PPL, enlarge the number of private pilots

颁布民用无人驾驶航空器系统驾驶员管理规定，建立培训体系，促进无人机发展

Publish provisions of civil unmanned aircraft systems pilots, establish UAS Pilots training system, boost UAS development in China
