

AOPA's "Pilot Passport State Badges" Contest Official Rules

WHO MAY ENTER:

Open to all individuals who legally reside in the 50 United States, the U.S. Virgin Islands and the District of Columbia 18 years of age or older who are the holders of a current FAA-issued student, sport, recreational, private, commercial, or ATP airman certificate. Employees of AOPA, its subsidiaries and affiliated companies, and the trustees, officers, directors, interns, advertising or promotion agencies of each, are not eligible to win. Any person in the immediate family of an employee (including the spouse, children, parents, brothers and sisters of any employee) living in the same household of any such employee is not eligible to win.

HOW TO ENTER:

To enter, fly to an airport, utilize the "Pilot Passport" feature within the AOPA app to check in during the Entry Period. For each check in during the Entry Period, you will receive points towards earning badges, and in some instances a state badge or state badges in accordance with the criteria found at <https://www.aopa.org/travel/pilot-passport>.

ENTRY DEADLINE:

The contest begins at 12:01 AM on October 1, 2019 and ends at 11:59 PM on October 31, 2019 (the "Entry Period"). All entries must be completed during the Entry Period.

JUDGING:

The three (3) individuals with the highest number of badges earned during the Entry Period as indicated by the Pilot Passport feature will be the Grand Prize winners. For clarification, points earned, and airports visited prior to the Entry Period may be used to earn badges during the Entry Period. Grand Prize winners will be notified via email, postal service, or phone.

PRIZES:

There will be three (3) Grand Prize winners. Each Grand Prize winner will receive a \$50 gift certificate to the AOPA Pilot Gear store. Approximate retail value ("ARV") of each Grand Prize is \$50.00. ARV of all Grand Prizes is \$150.

MISCELLANEOUS:

Each participant agrees that any and all disputes and causes of action arising out of this contest shall be resolved individually and any judicial proceeding shall take place in a federal or state court within the State of Maryland. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and AOPA in connection with the contest, shall be governed by and construed in accordance with the laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Maryland or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Maryland. All federal, state and local taxes, fees and other expenses are winner's responsibility. By entering the contest, contestants grant the Aircraft Owners and Pilots Association a non-exclusive license

to publish, display and otherwise use the names and likenesses of the winners, in print or electronic form on AOPA electronic media and/or in a future issue or issues of print publications, for advertising and promotion of AOPA. By entering this contest each participant agrees to be bound by these Official Rules and the decisions of AOPA and its judges, whose decisions regarding all aspects of the contest shall be final.
