Kelli demonstrates all principles and recommended practices listed in the Code of Conduct. She exemplifies the characteristics of a Model Flight Instructor in all her actions. My reference submitted to the flight school on her behalf is below: I recently received my PPL in an Archer using various instructors. Each was good, but their main goal was to build time while instructing me techniques to specifically to pass my check ride. We own a Cirrus, so after achieving my PPL, I utilized Kelli as my CSIP for transition training. From the first moment, I was taken back with Kelli's enthusiasm for flying.
